1. On September 19, 2003, this Court issued a Temporary Restraining Order, Order Appointing Receiver, Order Freezing Assets and Order for Accounting ("Order") entered in this matter on September 19, 2003.


2. The Order appointed Win Holbrook to act as Receiver for Defendants Sunset Financial Group, Inc., Vision Services, Inc., Amsterdam Fidelity Business Trust, EASE Corporation and Betty Solomon Brokerage, Inc.

3. The Department requests that the Receiver file with the Clerk of the Oklahoma County District Court a bond in the sum of Fifty Thousand Dollars (\$50,000.00).

4. The Department reports that P. David Newsome, Jr. of Conner & Winters, attorney for Defendants Amsterdam Fidelity Business Trust, Rebates International, Inc., Grover H. Phillips and Terry Mahon; Terry Kordeliski of Riggs, Abney, Neal, Turpen, Orbison & Lewis, attorney for Defendants Betty Solomon Brokerage, Inc. and Betty G. Phillips; and Mark S. Edmondson of Miller Dollarhide, attorney for Gold Star Properties, Inc., Charles E. Elliott and Nicholas Krug have no objection to this application. The Department has no knowledge that Defendants Sunset Financial Group, Inc., Vision Services, Inc., EASE Corporation, Denver Large or Donald J. Wood are represented by counsel. The Department was unable to reach counsel for Emzie Huletty.

Therefore, the Department respectfully requests that this Court order that Receiver, Win Holbrook, file with the Oklahoma County District Court a bond in the sum of Fifty Thousand Dollars (\$50,000.00).
