**FINAL JUDGMENT**

This matter comes on for hearing on July 16<sup>th</sup>, 2003, before the undersigned Judge of the District Court in and for Tulsa County, State of Oklahoma, for an order of restitution and/or other equitable relief. The Oklahoma Department of Securities (Department) appears through its attorney, Rebecca A. Cryer. Defendants, Charles R. Chung and J. Elaine Chung, appear through their attorneys, James C. Lang and Patrick O. Waddel. Defendants, Parakletos Professional Services L.L.C., Parakletos Investment Club and Parakletos Investment Club II appear through Charles R. Chung and J. Elaine Chung. The Receiver, Neal Tomlins, appears *pro se*.

For the purpose of this Judgment only, the Defendants agree that the Court may enter this Judgment:

1. Beginning on or about May 1, 1999, through December 31, 2000, Defendants collected approximately \$2,869,343.00 from various persons (Investors).

2. Of the amount collected from the Investors, Defendants have returned to certain Investors the amount of \$731,720.00.
3. There remains a total amount of \$2,137,623.00 to be returned to Investors in proportion to the amounts of their investments, less any amount previously received from Defendants.
4. The Receiver presently has in his possession and control the amount of \$109,733.00 available for return to the Investors, which amount is net of estimated fees and expenses of the Receiver and his Counsel in the amount of \$25,111.00.

**IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that the Receiver shall distribute the funds in his possession and control to the Investors that is, \$109,733.00, in proportion to the amounts specified in Appendix "A" attached hereto.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that Defendants, jointly and severally, make restitution in the amount of \$2,137,623.00 through payment to each Investor in proportion to the amounts specified in Appendix "A" attached hereto, and that this judgment shall be non-dischargeable under the provisions of 11 U.S.C. § 523(a)(2).

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that this is a Final Judgment resolving all issues presently existing between the Plaintiff and Defendants in this action.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that this Court will retain jurisdiction of this matter for the purpose of enforcement of this Judgment.


