AGREED PROTECTIVE ORDER

Upon consideration of the motion of Defendants for a protective order regarding the scope, timing, and confidentiality of discovery, it is hereby ordered that the motion is granted and the following protective provisions be, and hereby are, imposed upon the scheduled discovery conducted by Plaintiff in this action, whether this discovery is directed at a party to the litigation, at Defendants or at any other person:

1. The documents made available for the Plaintiff's review shall be treated as confidential and are subject to this protective order.
2. The Plaintiff's agents, employees, representatives, other counsel or any other person are subject to this Protective Order.
3. The Oklahoma Department of Securities will be allowed to review and inspect the documents produced on October 16, 2006, in an unredacted form.
4. The Oklahoma Department of Securities will not make copies of documents at the time of their initial review. Defendants shall make copies of any documents requested by Plaintiff with the following information redacted: (Confidential

Information).


5. The Oklahoma Department of Securities will not use the Confidential Information obtained during its review for any purpose. However, should the Department believe it is necessary to use an unredacted document in the course of this litigation but cannot reach an agreement with Defendants, the Department may petition the Court regarding the production and subsequent use of the document for purposes of litigation.
6. The Oklahoma Department of Securities will not communicate, reveal or disclose the Confidential Information obtained during their review of these documents to any third party, except by order of this Court.

The Court hereby grants the Agreed Protective Order requiring the Plaintiffs to follow the above guidelines for inspection of the documents.


