**CORRECTION TO ORDER APPROVING REPORT OF OKLAHOMA DEPARTMENT
OF SECURITIES, INVESTOR CLAIM DESIGNATIONS AND PARTIAL
DISTRIBUTION TO INVESTORS**

This matter came on for hearing this 18 day of Oct, 2007, before the undersigned Judge of the District Court in and for Oklahoma County, State of Oklahoma, to correct a designation on Plaintiff's report to the Court regarding the claim made by claimant number 119 (Investor 119) who invested a net sum of \$11,897.00 with Defendants Raglin Industries, LLC, Phillip Levaughn Raglin and Joseph Daniel Layne (collectively, "Defendants"), but whose claim designation was reported to be \$11,297.00. Plaintiff appears by and through its attorney, Patricia A. Labarthe. Based on newly discovered evidence, Investor 119 was entitled to a designated claim of \$11,897.00. After considering the evidence, the Court finds that the corrected amount should be approved.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Investor 119's designated and allowed claim be increased by \$600.00.

IT IS FURTHER ORDERED that upon receipt by Bank of America of the transfer of funds from Account Number 707831202 at JP Morgan Chase Bank, Bank of America issue a cashier's check to Investor 119, from the Raglin Industries LLC Account Number 3040170230, in the name and at the address to be provided to Bank of America by Plaintiff, and in the additional prorated amount of \$249.39.

IT IS FURTHER ORDERED that Bank of America issue and mail the cashier's check and provide a copy of the cashier's check to Plaintiff no later than twenty (20) days from the date of this order.

IT IS FURTHER ORDERED that Bank of America is authorized to debit a reasonable fee from Raglin Industries LLC Account Number 3040170230, that does not exceed Six Dollars (\$6.00), for the issuance of the check to Investor 119.
