ORDER

On this 18th day of January, 2008, this matter comes before the undersigned Judge of the District Court in and for Oklahoma County, State of Oklahoma, upon the *Motion to Release Vehicle* filed herein by Defendants.

The Court, having reviewed all pleadings and submissions of the parties, finds that the motion be and hereby is granted and, therefore:

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that one 2007 model Chevrolet truck, bearing vehicle identification number 3GCEK13M67G532024, be released from the provisions of the Temporary Injunction issued by the Court in this matter on January 9, 2008. Such release is conditioned upon the following:

1. such release shall be effective only upon the sale of such vehicle for fair market value to any person other than Defendants or their agents, servants, employees, subsidiaries, and those persons acting under the direction and/or control of Defendants;
2. such sale shall be conducted in accordance with the terms and conditions of Mark A. Wingo's release from federal custody and his


ongoing supervision by the United States Probation Office, United States District Court for the Northern District of Oklahoma; and


3. all proceeds received from the sale of the referenced vehicle shall be immediately deposited into account number xxxxxxxx1647, maintained by RCB Bank in the name of Airgonomics, Inc. Such proceeds may then be withdrawn in an amount necessary to release any security interest(s) applicable to the referenced vehicle. Any proceeds in excess of any amount(s) necessary to release any security interests(s) shall remain in the referenced account and shall remain subject to the asset freeze portion of the Temporary Injunction issued by the Court on January 9, 2008.


