**RECEIVER'S EMERGENCY APPLICATION TO SELL CATTLE**

COMES NOW the Receiver for his Emergency Application to Sell Cattle and states as follows:


1. On November 4, 2009, Douglas L. Jackson was appointed Receiver of the Assets which include cows and calves owned by Bryan David Roark.
2. The Receiver has approximately 89 calves weighing 500 to 600 pounds that are scheduled to be sold in a special calf sale at the LeFlore County Livestock Auction in Wister, Oklahoma on November 10, 2009.
3. Chad Roark, the son of Bryan David Roark, has 82 calves weighing from 550 to 700 pounds that are also scheduled to be sold in LeFlore County Livestock Auction on November 10, 2009.
4. These calves should be sold on November 10, 2009, rather than the Receiver incurring additional costs in keeping these calves through the fall and winter.
5. The 89 calves owned by Bryan David Roark will be sold in the name of the Receiver and the 82 calves owned by Chad Roark which will be sold in the name of Chad Roark

and the Receiver so that the Receiver can determine what claim if any the Receiver will make against said proceeds.

6. The Oklahoma Department of Securities supports this Application and Christy Roark, the widow of Bryan David Roark, also supports this Application.

**WHEREFORE**, the Receiver prays that the Court enter an Emergency Order, instanter and without notice, authorizing the Receiver to sell the cattle referenced herein and for such other and further relief.
