JUDGMENT AND SENTENCE

This case came on for trial before this Court on July 18, 2011. Present for the Plaintiff, Oklahoma Department of Securities, *ex rel.* Irving L. Faught, Administrator, was its counsel, Patricia A. Labarthe and Jennifer Shaw. Defendant Joe Don Johnson did not appear.

The Court finds as follows:

1. that Defendant failed to make monthly payments of restitution of Five Hundred Dollars (\$500.00), beginning September 15, 2010 and continuing to the present date, in violation of the *Permanent Injunction Against Defendants Heritage Estate Service LLC and Joe Don Johnson* (Permanent Injunction) and *Defendant Joe Don Johnson Agreed Order of Restitution* (Restitution Order);
2. that Defendant failed to provide the Plaintiff with a copy of his paycheck to verify his monthly income on or before September 15, 2010, in violation of the Permanent Injunction and Restitution Order;
3. that Defendant failed to provide the Plaintiff with financial statements on or before March 1 and September 1 of each year regarding his monthly income to allow

Plaintiff and the Court to reevaluate his monthly restitution payment amount, in violation of the Permanent Injunction and Restitution Order;

4. that Defendant's failures to make the restitution payments and submit documentation of his monthly income and financial statements above constitute violations of this Court's Permanent Injunction and Restitution Order and are instances of indirect contempt of Court; and

5. that Defendant knowingly, willfully and contemptuously disobeyed and violated this Court's lawfully issued Permanent Injunction and Restitution Order.

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED by the Court that the Defendant, Joe Don Johnson, is guilty of indirect criminal contempt of court for disobedience of the Permanent Injunction and Restitution Order entered by the Oklahoma County District Court, and is sentenced to six (6) months confinement in the Oklahoma County jail under the custody and control of the Oklahoma County Sheriff and payment of a \$500.00 fine.
