**ORDER ALLOWING WITHDRAWAL OF ROBERT G. MCCAMPBELL AND

IT IS FURTHER ORDERED that Defendant Storybook Properties, LLC and Defendant Storybook Investments WA, LLC shall, within thirty (30) days of the entry of this order secure an entry of appearance by other counsel.

IT IS FURTHER ORDERED that the failure of Defendant Matthew G. Story to enter an appearance pro se or by successor counsel within 30 days of the date of this Order may result in dismissal of the case without prejudice or a default judgment.

IT IS FURTHER ORDERED that the failure of Storybook Properties, LLC and Storybook Investments WA, LLC to enter an appearance by successor counsel within 30 days of the date of this Order may result in a dismissal of the case without prejudice or a default judgment.

IT IS FURTHER ORDERED that upon execution of this Order, and until such time as the Storybook Defendants exercise one of these options, service of all documents filed in this

cause may be accomplished by United States mail in accordance with 12 O.S. § 2005(B).

Service of this Order shall be made upon the Storybook Defendants by e-mail and certified mail.


