JUDITH KARYN SEABROOKE FINAL ORDER

On this 18th day of December, 2015, Plaintiff, Oklahoma Department of Securities ex rel. Irving L. Faught, and Defendant Judith Karyn Seabrooke (Defendant), agree to the entry of this *Judith Karyn Seabrooke Final Order* (Order).

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the *Stipulation and Consent of Judith Karyn Seabrooke* (Stipulation and Consent) is incorporated herein by reference and that the Defendant shall comply with all of the undertakings and agreements set forth therein.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the homestead of Defendant and her husband, Defendant Tom W. Seabrooke, located at 3040 Hemingford Lane, Oklahoma City, Oklahoma 73120 (Homestead) is released from the Receivership and from any claim of the Plaintiff or the Receiver.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that, except as to the Homestead being released from the Receivership, Defendant has waived any and all rights, claims, or ownership in and to all assets, properties, and/or funds of the Receivership estate, whether or not currently under control of the Receiver, including but not limited to all

commissions or other compensation earned by Defendant from the sale of properties of the Receivership and in the Receiver's possession pursuant to this Court's previous order covering the same.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Receiver and the Plaintiff are released and indemnified by Defendant from and against and all liability, claims and loss of any kind whatsoever relating to or arising out of any acts or omissions of the Receiver and/or the Plaintiff in these proceedings or involving the Receivership estate.




