**ORDER REQUIRING NOTICE TO CLAIMANTS OF
RECEIVER'S REPORT ON CLAIMS AND RECOMMENDATION
FOR CLASSIFICATION OF SAME, ESTABLISHING
TIME TO RESPOND AND SETTING HEARING**

On this 22nd day of Dec, 2015, having been apprised of the filing of the Receiver's
Report on Claims and Recommendation for Classification of Same ("Receiver's Report"), the
Court orders that the Receiver shall:

- (1) Serve notice upon all claimants by certified U.S. Mail of a file-stamped copy of the Receiver's Report and a copy of this Order;
- (2) Through service of this Order, notify all claimants that each claimant shall be allowed thirty (30) days from the date of ~~service by the Receiver~~ ^{This Order (pp)} to file a responsive pleading to the Receiver's Report, and that any party shall be allowed an additional twenty (20) days from the filing of a response to file a reply;
- (3) Notify all claimants that a hearing is set before this Court on Feb. 29, 2016 @ 9:00 A.M. 2016, where any claimant shall appear before the Court to present any objection to the recommendations made within the Receiver's Report, and the Court shall fully and finally adjudicate all claims, unless a separate hearing on a particular claim is otherwise specially set.


