
**ORDER APPROVING CONSERVATOR'S REPORT AND

OF MAY 1, 2014 THROUGH SEPTEMBER 30, 2014**

NOW on this 31st day of October, 2014, the application of Conservator, Tom Moran, for entry of an Order approving the interim application for Conservator's fees and expenses for the period of May 1, 2014 through September 30, 2014, came on for consideration before the undersigned Judge. The Court having reviewed the application, being advised that Plaintiff has no objection to the granting of this application, and no objection being filed by Defendants, finds that the Conservator's Application should be granted for good cause shown. The Court further finds that the Conservator's Report for the period of May 1, 2014 through September 30, 2014 should be approved.
