DEFAULT JUDGMENT AGAINST ROBERT J. SEITTERS

This matter came on for hearing this 13th day of January, 2006, before the undersigned Judge of the District Court in and for Oklahoma County, State of Oklahoma, upon the Plaintiff's Petition for Permanent Injunction and Other Equitable Relief (Petition) against Robert J. Seitters (Seitters).

The Court, having reviewed the Petition, summons, return of service and court file, finds that Seitters has been validly served with the Petition and summons, that the date by which Seitters was required to appear and defend this action was January 11, 2006, and that no appearance has been made by Seitters, nor has any motion or pleading been filed on his behalf. Seitters is in default and has thus admitted the allegations of the Petition.

It appears to this Court from the facts alleged in Plaintiff's Petition and being fully advised in the premises, and on consideration thereof, finds that Plaintiff is entitled to the relief for which it has prayed against Seitters.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Seitters, his agents, servants, employees, assigns and all those persons, directly or indirectly, acting on his behalf, under his direction and control, and/or in active concert or participation with him be and hereby are, permanently enjoined from, directly or indirectly, offering or selling any security in and/or from this state.

IT IS SO ORDERED.
