

ORDER SETTING HEARING

WHEREAS, on November 23, 2005, the Enforcement Division submitted to the Administrator of the Oklahoma Department of Securities (Administrator) its Recommendation (Recommendation) to deny or condition the registration of Joe E. Poe, Jr. (Poe) as an agent of Equity Station, Inc. (Equity Station).

WHEREAS, on November 23, 2005, the Administrator issued a Notice of Opportunity for Hearing (Notice) based on the Recommendation.

WHEREAS, on November 23, 2005, a copy of the Notice with a copy of the Recommendation attached was sent by certified mail, return receipt requested, delivery restricted to addressee, to the last known addresses of Poe and Equity Station, in compliance with Section 1-611 of the Oklahoma Uniform Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2003).


WHEREAS, a written request for hearing on the Recommendation was received by the Department on behalf of Poe on December 8, 2005.


