**ORDER BARRING FROM REGISTRATION
UNDER THE ACT AND BARRING FROM ASSOCIATION
WITH A BROKER-DEALER AND/OR INVESTMENT ADVISER**

Pursuant to the Oklahoma Uniform Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2009), the Administrator of the Oklahoma Department of Securities (Department) issues this Order barring Respondents Legacy Trading Co. LLC and Mark Alan Uselton (collectively, the "Respondents") from future registration under the Act in any capacity, and barring Respondent Mark Alan Uselton from association with a broker-dealer or investment adviser in any capacity.

The Department conducted an investigation into the activities of Respondents to determine whether violations of the Act and/or the Rules of the Oklahoma Securities Commission and the Administrator of the Department of Securities (Rules) may have occurred.

Based thereon, an *Enforcement Division Recommendation* (Recommendation) was filed with the Administrator on December 10, 2010, in support of the imposition of a sanction against Respondents, in the form of a bar. The Administrator issued a Notice of Opportunity for Hearing with the Recommendation attached (Notice) on December 10, 2010. Respondents had fifteen (15) days after service of the Notice to request a hearing.

Pursuant to Section 1-611 of the Act, service on Respondents was made by serving the Administrator on December 10, 2010. Pursuant to Section 1-611 of the Act, the Notice was mailed to Respondents, by certified mail, return receipt requested, and delivery restricted. On December 20, 2010, the Recommendation and Notice mailed to Respondent Legacy Trading Co. LLC were returned marked not deliverable as addressed. On December 11, 2010, the Recommendation and Notice mailed to Respondent Mark Alan Uselton were signed for by Mark Uselton. No request for hearing has been received by the Administrator.


The Administrator, being fully advised in this matter, finds that the issuance of this Order is in the public interest and hereby adopts the Findings of Fact and Conclusions of Law set forth in the Recommendation.

IT IS HEREBY ORDERED that Respondents Legacy Trading Co. LLC and Mark Alan Uselton are barred from future registration under the Act in any capacity.

IT IS FURTHER ORDERED that Respondent Mark Alan Uselton is barred from association with a broker-dealer and/or investment adviser in any capacity including, but not limited to, any ministerial or clerical capacity.


