**ORDER GRANTING MOTION TO COMPEL**  
**DEFENDANTS TO PRODUCE PROPERTY**

There came on for hearing on March 11, 2004, the motion to compel production of certain receivership property (the "Motion") currently under the custody, control and possession of Sunset Financial Group, Inc., Vision Services, Inc. (the "Receivership Defendants") and/or the agents, employees, principals or representatives of the Receivership Defendants, and/or Emzie Huletty, Grover H. Phillips, Betty G. Solomon and Donald J. Wood (the "Individual Defendants"), filed by L. Win Holbrook, the duly appointed receiver in the above styled and numbered proceeding (the "Receiver"). Parties appeared as stated in Court.

After hearing and considering statement of counsel and the testimony offered, the Court finds that the Motion shall be, and hereby is, granted.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED the Receivership Defendants, and/or the agents, employees, principals or representatives of the Receivership Defendants, and/or Emzie Huletty, Grover H. Phillips, Betty G. Solomon and Donald J. Wood, shall immediately produce and surrender to the Receiver the 2001 Dodge Durango, VIN 1B4HR28N21F521947; and

IT IS FURTHER ORDERED, ADJUDGED AND DECREED the Receivership Defendants, and/or the agents, employees, principals or representatives of the Receivership Defendants, an/or Emzie Huletty, Grover H. Phillips, Betty G. Solomon and Donald J. Wood, shall assist the Receiver to effectuate the immediate production and surrender of the 2001 Dodge Durango, VIN 1B4HR28N21F521947; and


