**ORDER OF RESTITUTION AND PAYMENT OF CIVIL PENALTY**

This matter came on for evidentiary hearing this 1st day of October, 2004, before the undersigned Judge of the District Court in and for Oklahoma County, State of Oklahoma. Plaintiff, Oklahoma Department of Securities, appears by counsel Amanda Cornmesser and Rebecca Cryer. Defendants Certified Mid-America Financial Group, Inc., Kriss K. Williams Jr., and Kriss K. Williams and Patricia G. Williams *dba* Kriss K. Williams Jr. Agency and Certified Mid-America Financial Group (collectively, "Defendants") appear not.

The Court, having examined the pleadings and the exhibits presented herein and having heard testimony presented by Plaintiff, finds that Plaintiff's request for restitution payable to the estate of Mildred Hoffman and for payment of a civil penalty to the Oklahoma Department of Securities should be granted.

**IT IS THEREFORE ORDERED** that Defendants shall pay restitution to the estate of Mildred Hoffman in the sum of One Hundred Three Thousand Four Hundred Forty-Two Dollars (\$103,442.00).

**IT IS FURTHER ORDERED** that Defendants pay the Oklahoma Department of Securities a civil penalty in the amount of Fifty Thousand Dollars (\$50,000.00).


