

ORDER VACATING
ORDER REVOKING REGISTRATION

1. On June 28, 2005, the Administrator (Administrator) of the Oklahoma Department of Securities issued an order to revoke the registration of Patrick J. Maroney as an agent of Legg Mason Wood Walker, Incorporated (Legg Mason), a broker-dealer, CRD No. 6555 (Order).

2. Counsel for Maroney (Counsel) has requested that the Administrator vacate such Order.

3. In consideration of this request, the following facts or representations of Counsel are noted:

a. Through the Central Registration Depository (CRD), Legg Mason had submitted an application to register Maroney as its agent under the Oklahoma Uniform Securities Act of 2004 (Act), Okla. Stat. tit. 71, §§ 1-101 through 1-701 (Supp. 2003).

b. After the registration of Maroney had become effective by operation of law on December 10, 2004, Maroney received notice from the Administrator of his intent to revoke such registration and the right to request a hearing to object to the revocation. Notice was also sent to Legg Mason at the office location of Maroney but not the home office of Legg Mason.

c. The circumstances of Maroney had changed, and he no longer needed to be registered in Oklahoma. Maroney communicated this information to Legg Mason and presumed any necessary action would be taken.


d. Due to error, no action was taken to withdraw Maroney's registration or to request a hearing on the proposed revocation.

ORDER

Based on an undertaking executed by Maroney on October 20, 2005, the Administrator deems registration withdrawn as of June 29, 2005, and the Order Revoking Registration issued on June 28, 2005, relating to Maroney is hereby VACATED.
