REPORT OF RECEIVER, STEPHEN J. MORIARTY  
REGARDING PERSONAL PROPERTY OF MERL WILLIAM  
HICKMAN, SR., SARAH L. HICKMAN, MERL WILLIAM  
HICKMAN, JR., CHRISTY HICKMAN AND  
STEPHANIE HICKMAN-MATTHEWS

Comes now Stephen J. Moriarty, the Court appointed Receiver for The Hickman Agency, Inc., Merl William Hickman, Sr., Sarah Hickman, Merl William Hickman, Jr., Stephanie Hickman-Matthews, Angela Friguletto, Peter Friguletto, Sandra Friguletto and Christy Hickman (collectively referred to as "Hickman"), and for his report to the Court regarding the sale of personal property owned by Hickman and located at their residences in Meeker, Oklahoma, states as follows:

1. On December 17, 2003, this Court entered its order appointing the Receiver; the appointment continued pursuant to the Temporary Injunction entered herein on December 22, 2003 (collectively referred to as the "Order"). Pursuant to the Order, Receiver was given immediate and exclusive custody, control and possession of all assets ... of Defendants, of whatever kind and description and wherever situated." Further, Receiver was given the authority to take the steps necessary to protect the interests of Investors, including the liquidation or sale of assets of the Defendants ..."

4. Receiver consulted with and retained Markwell Auction and Real Estate, Meeker, Oklahoma ("Markwell") regarding the value of the property and plans for a sale.


5. After consultation with Markwell, Receiver decided that it was in the best interest of the Investors to conduct a public auction of the property. On March 10, 2004 Receiver and Markwell entered into a Contract regarding the conduct of the auction; a copy of said Contract is attached hereto as Exhibit "A". Markwell agreed to discount its normal auctioneers fee of 15% to 12 ½%.

6. A public auction for the property was set for 10:00 A.M on April 3, 2004 at residences in Meeker, Oklahoma. Prior to the auction, Markwell prepared the property for sale, prepared and distributed promotional materials and ran advertisements regarding the auction; a copy of the report of Markwell pre-sale activities is attached hereto as Exhibit "B".

7. On April 3, 2004 the auction was held. Six hundred and forty seven (647) bidders registered to participate in the auction. It is estimated that over two thousand (2,000) people were in attendance were in attendance. Exhibit "C" sets forth information regarding the successful bids.

8. Gross sales of \$88,953.09 were realized at the auction. Expenses, including commissions and sales taxes of \$15,268.34 were paid. The auction netted \$73,684.75. A copy of the Closing Statement presented by Markwell is attached hereto as Exhibit "D". The sales proceeds have been deposited for the benefit of the Investors.



Dear Mr. Moriarty:

Enclosed please find an itemized accounting of every item sold at the Hickman property on Saturday, April 3, 2004 to help recoup the investors' losses.

We again thank you for the confidence and trust extended by you to Markwell Auction & Real Estate so that we could prepare the items listing, move items from the other two mobile homes to Hickman Sr's place, prepare and distribute the sale bills and place other appropriate advertising, sort and box items for sale, including repairing items where we felt necessary, put items in order for the best results on sale day, hire security and finally, on Saturday, to work at getting the highest possible money for the investors.

Following is a more detailed breakdown of our preparation for the auction and the day of the sale:

- March 16.....List items for sale bill and began to box items at Sr's mobile home. (2 extra persons hired to help this day).
- March 18..... Prepared sale bill.
- March 19..... Took sale bill to printer
- March 22..... From Stephanie's mobile home, took clothing to wash, dry, fold and box for sale.
- March 23.....Sorted and boxed ladies' clothing for sale & boxed items on shelves in garage. (2 extra persons hired for this day)
- March 24..... Boxed items at Stephanie's mobile home, moved some furniture items. (1 extra person hired for moving large items to Sr's place).
- March 24.....Prepared ads and sent them to Shawnee News & Sunday Oklahoman
- March 25.....Sale bills distributed in the immediate area.
- March 25.....Boxed more items from Stephanie's and put them in Sr's garage. (1 extra person hired for 4 hrs late afternoon)
- March 25.....Extra person hired to distribute sale bills in the Norman-Moore area.
- March 26.....Sale bills distributed in Meeker, and areas to the North and East
- March 29.....Took 4 wheelers to Loy's Auto for some tune-ups; moved TV's and larger furniture at Stephanie's to Sr's; moved Jr's TV and Tools to Sr's. (1 extra person hired to help move items and work at Sr's).
- March 30.....Worked at Stephanie's boxing small items
- March 31..... Worked at boxing items in Sr's house and moved more items to garage. (1 extra person hired for this day)
- April 1... ..Moved items in the yard to front yard where items would be sold; cleaned out storeroom; worked in storage building moving some items to front yard and lined some west of garage for sale; picked up 4 wheelers and placed them in line for sale day; hired security for Friday Night and Saturday ; Ordered Portie Pottie for Saturday; (1 extra person hired to help this day until late)
- April 2.....Last day before sale; finished cleaning out storage building and boxed items; Mowed immediate front yard to line up boxes and put 4 tables in line; took all outside-sale items from house to yard rows; numbered guns, exercise equipment, furniture in house, decking, awning, Big Country, Segways and 4 Wheelers; took items from garage and arranged in rows; had electrician to remove Coca Cola Light/Fan from small room in Sr's mobile home and replace with another light fixture; ( 3 extra persons to help from 8:30 AM to 6:45 that evening)
- April 3.....Sale Day: moved two tables outside to first row; began registering at 8:30AM; hired 2 extra persons just to register (in addition to regular help). (Staff on sale day totalled 10 plus Vernon and Gail Markwell.

April 4.....Went to sale site from 2:00 to 4:00 pm to assist if needed  
April 6.....Went to pick up wheel barrow and items in attic of the garage to sell at our April 17 sale for the receiver; however, these items were gone.  
April 6.....Hired one person to clean up trash and boxes at Sr's home  
April 7.....Went to Srs to get anything left to sell at the April 17 sale; completed typed inventory of sale.

We will send you the money for the shrubs at Stephanie's we sold after the auction and any proceeds from items we took from Sr's (that were left) to our April 17 sale.

Again, we appreciate very much the opportunity to work with you, and the confidence you placed in us. We feel that the sale went extremely well, with nearly all items selling at top dollar to a great crowd. We felt that everything went very well on sale day.
