



- A. Any and all documents with any modifications or updates of the materials showing such representations. Include any supplemental information if provided or available.
 - B. Include any and all transfer documents or interests being transferred.
2. In paragraph 7, of the recommendation, you have indicated that respondents are representing that there is "constant growth and "sprawl" of the city of Las Vegas, and "The trend clearly shows more than a trebling of values in a 6 year period..."

PLEASE PRODUCE FOR INSPECTION:

- A. Any and all documentation with any modifications or updates, or supporting materials indicating such representations.
 - B. Include any and all documentation the supports or verifies any representations regarding the growth, and Federal Land Sales associated with said representations.
3. In paragraph 8, of the recommendation, you indicate that respondents represent that purchaser will recieve a claim in a area pre-designated by EMS. Also that EMS with their "knowledge and expertise" will maintain the claims in good standing.

PLEASE PRODUCE FOR INSPECTION:

- A. Any and all documentation with any modification or updates, or supporting material regarding the representations.
 - B. Include any and all documentation explaining or supporting the representations.
4. In paragraph 7, of the recommendation, you indicate .."to provide investment returns,...the purchaser may grant "NMPC a "right of first refusal..."

PLEASE PRODUCE FOR INSPECTION:

- A. Any and all documentation with any updates, or modifications, or supporting material regarding the representations, include if available options regarding the consideration for said "first right of refusal." (i.e. additional land option)
- B. Include any and all documentation explaining the "first right of refusal," and the purpose of said agreement.
