

TRUSTEE'S APPLICATION TO PAY SECURED CREDITOR

JANICE D. LOYD, Trustee, respectfully applies to the Court for an Order authorizing her to pay over to the secured creditor, Liftruck Parts and Service, the amount of \$1,605.66 representing payment of its secured lien out of sale proceeds to be received from the sale of estate assets located in Sallisaw, Oklahoma. In support of said application, the Trustee would advise the Court that she filed her Motion for Order authorizing her to sell personal property located in Sallisaw, Oklahoma, to Steve D. Blount on the 28th day of October, 2003. On November 20, 2003, the Court entered its Order authorizing the Trustee to proceed with the sale. That Liftruck Parts & Service holds a secured lien on a Komatsu pneumatic tired forklift Model FD25 Serial No. 472357 which said lien will attach to the sale proceeds to be received by the Bankruptcy Estate. The trustee has determined that the amount due and owing to Liftruck Parts & Service is \$1,605.66.

WHEREFORE, the Trustee, Janice D. Loyd, respectfully prays the Court issue an Order authorizing her to pay over to Liftruck Parts & Service the sum of \$1,605.66 in payment of the secured lien on the Komatsu pneumatic tired forklift Model FD25 Serial No. 472357 located in Sallisaw, Oklahoma, being specifically described in Trustee's Motion, out of the sale proceeds received by the bankruptcy estate, and for such other and further relief as is just and equitable.


